Cease and Desist all Government assisted Refugee programs effective February 1, 2022.

Financial Assistance provided to Refugees cannot exceed one thousand dollars monthly (\$1,000.00) and for a maximum of three (3) months only. This one thousand dollar is the total combined assistance from all agencies/departments.

Nullify and Void all authority of Private individuals (group of 5), Churches, NGOs, Foundations, and Charity Status, to sponsor Refugees into the Kingdom of Canada.

Cease and Desist (null and void) all Refugee Resettlement Agreements Internationally.

Re: Permanent Residents Status

Effective immediately those holding permanent resident status (PR Status) in the Kingdom of Canada must be in the Kingdom of Canada for a total of one thousand seven hundred ninety-five (1795) days out of five years or for one thousand eight hundred twenty-five (1825).

Cease the Permanent Resident Status of any permanent resident status holder who has been proven disingenuous in their behavior and conduct in dealing with We The People of Canada resulting in financial, material, physical and psychological harm and loss to any members of We The People of the Kingdom of Canada.

Further, these individuals are to be immediately removed from the Kingdom of Canada within four (4) hours of his/her Refugee Status ceasing.

Conduct an Immediate Removal of all unlawfully resettled Refugees in the Kingdom of Canada from Countries where wars (real and or imagined) were manufactured by Foreign Governments and/or their own Governments.
