Ensure all Borders between the Kingdom of Canada, the US, and Mexico remain open 24 hours a day 365 days a year.

All Registered Truckers/Truck Drivers delivering essential goods and supplies to and from the Kingdom of Canada, the US, and Mexico are to be admitted and unhindered.

All Provinces and Territories' Borders are to remain open 24 hours a day 365 days a year to all Truck Drivers/All Canadians traveling to and from their intended destinations unhindered.

All Sea and Air Ports in the Kingdom of Canada, are to be in full operation 24 hours a day 365 days a year with special attention to food deliveries.

Ensure extra personnel are added where required

Ensure all foods/produce are offloaded from all Ships/Planes and delivered to their final destinations across the Kingdom of Canada, the US, and Mexico.

This Royal Decree is effective immediately.

Death penalties are to be carried out as soon as possible or within twenty-four (24) hours upon conviction by means of:

Public hanging (city square or designated Island in the Kingdom of Canada – public viewing restricted to adults age 24+).

Firing squad (city square or designated Island in the Kingdom of Canada – public viewing restricted to adults age 24+).

All injections/medications/MRNA therapies target, alter, and destroy the mucosa of the lung and all major organs in human species and animals.

Unlawful collection of individual DNAs via PCR testing, Rapid Testing, or any form of testing and or collection thereof and thereto.

Furthermore, it is a criminal offense in the Kingdom of Canada to:

Use of facial masks in public and business settings that hinders the facial recognition and identification of individual(s) which could aid/facilitate in criminal activities (ie kidnapping, hold-ups, carjacking, robbery, child abduction, etc, etc).

Unlawful enforcement of the use of masks both in public and private settings.

Note: Exemptions are:

- 1) Construction sites where dust masks are used.
- 2) Dentists' office during oral procedures.
- 3) Hospitals operations rooms (OR) only.

Canadians

Landed Immigrants, And
Permanent Residents

The total amount, for Individual Renters, is \$300.00 to \$1,800.00 (maximum per Household).

The total amount, for Family Renters, is \$1,200.00 to \$3,500.00 (maximum per Household).

Applicants must present verifiable rental agreements

*Income vs Rental Residential Expenses threshold is, 1/3, of 100% net income of the applicant.
For example, if the total net income is \$100.00, a maximum of 33% or \$33.00 goes to rent.

Department of Treasury/Ministry of Finance is hereby instructed to immediately coordinate and facilitate the acceptance of applications, processing, and direct disbursement of funds directly to the Rental Agencies/Building Owners Account.

Please, ensure that We The People can apply for their rent Subsidies effective January 30, 2022. Hire up to 500 individual clerks to process the We The Peoples Application.

Review, Approval, and disbursement of funds for each applicant should be completed within 3 business days. No later.

- 1) Arrest, try, and prosecute all contraband drug traffickers and manufacturers under crimes against humanity.
- 2) Search, seize and confiscate and safely destroy (in public view) all confiscated contraband drugs, and their equipment.
- 3) Arrest all Politicians, Bureaucrats, Healthcrats, Indigenous Chiefs, and Band Members involved in the sale, trafficking, and manufacturing of illegal drugs and adrenochrome production.
- 4) Build temporary Hospitals where necessary –treatment and recovery Centers and provide adequate staffing for each Territory for all drug users to recover and reintegrate into the community.
- 5) Patrol and Secure each Territory to block the flow of illegal drugs in each Territory that are being shipped from outside the Territories.
- 6) Where necessary invoke a nightly curfew – from 6:00 pm to 6:00 am until all drug trafficking and manufacturing activities have stopped.
- 7) Do daylight, and door-to-door knocking to ask drug users, drug dealers, and manufacturers to voluntarily surrender.

- b) Cancel and confiscate all Passports (including diplomatic passports).
- c) Cancel All Diplomatic immunity worldwide.
- d) Place the named individuals on a no-fly list.
- e) Arrest the named individuals at any time they appear at any ports (Air, Land, and Sea) to exit/enter the Kingdom of Canada.

- f) Hold the individuals until further instruction has been received from the International Court.
- g) Freeze all Bank Accounts in their names.

This Royal Decree is effective immediately.

- 1) Immediately evacuate all Canadian Citizens from the Country of Ukraine due to possible Armed.

2) Temporary and immediate closure of all Kingdom of Canada's Embassy/Consulate Offices in the Country of Ukraine.

3) Evacuation activities must be carried out twenty-four hours a day until all Canadians in the Country of Ukraine have been evacuated via Military Aircraft back to the Kingdom of Canada.

This task must be accomplished on or before January 29, 2022.

This Royal Decree is effective immediately.

Cease and Desist all financial expenditures related to NATO activities foreign and domestic.

Freeze and return all unspent funds (allocated for NATO) up to today to the National Treasury of the Kingdom of Canada Forward this Decree to parties concerned as required.

This Royal Decree is effective immediately.
