Some of the Natural Law Decrees include consequences and others do not. Those without consequences are to be tried in court of Natural Law and it is up to the jury of 12 to determine whether the accused is guilty and what the retribution and/or penalty will be imposed.

Title : Right to Travel
Area: Borders/Immigration/Migration

Description:

We the people have the right to travel freely in and out of the Kingdom of Britain, without:

- Requiring proof of Corona 19 Virus Vaccination Passport
- Requiring Corona 19 Virus related protective facemasks
- Requiring Corona 19 Virus related quarantine
- Requiring testing for Corona 19 Virus
- Requiring Corona 19 Virus Track and Trace

This is applicable to all other man-made viruses designed to oppress we the people.

Consequence:

Doing so renders all border control an active participant in intentional genocide and crimes against humanity.

Title : Illegal immigrants, Refugees, Asylum seekers and Students financial assistance for re-patriation

Area: Borders/Immigration/Migration

Description:

Illegal immigrants, Refugees, Asylum seekers that have entered the Kingdom of Britain who have been proven disingenuous towards We The People causing harm and/or loss to We The People.

Illegal immigrants, Refugees, Asylum seekers that have entered the Kingdom of Britain without express permission.

International students who attend education in the Kingdom of Britain.

Exceptions: See Natural Law Decree 01.003.01

Consequence:

Those Illegal immigrants, Refugees, Asylum seekers who have caused harm and/or loss within the Kingdom of Britain will be returned immediately to their country of origin. Funding will be made available for a commercial one-way plane ticket.

Those who have entered without express permission will be returned within 3 months to their country of origin. Funding will be made available for a commercial one-way plane ticket.

International students are prohibited from accessing and disqualified from receiving education and financial assistance within the Kingdom of Britain. All international student work visas are also terminated. The students will be returned within 30 days to their country of origin. Funding will be made available for a commercial one-way plane ticket. For large groups the Kingdom of Britain military aircraft can be used.

Title : Settled Immigrants
Area: Borders/Immigration/Migration

Description:

Immigrants who have been working and have permanent residence or renting in the Kingdom of Britain for more than 1 year, are permitted to stay and contribute to the Kingdom of Britain and will be classed as Kingdom of Britain citizens.

Title : Military Personnel unlawfully dismissed and unlawfully promoted
Area: Defence/Military

Description:

All military personnel of the Kingdom of Britain who have been unlawfully dismissed and politically persecuted.

All promotions that resulted directly from these dismissals

Consequence:

Immediate reinstatement of all those unlawfully dismissed.
Dismissal of all those unlawfully promoted.

Area: Defence/Military

Description:

Ex-military personnel, veterans and territorial army personnel are offered the opportunity to re-deploy in the military to assist with Kingdom of Britain transition.

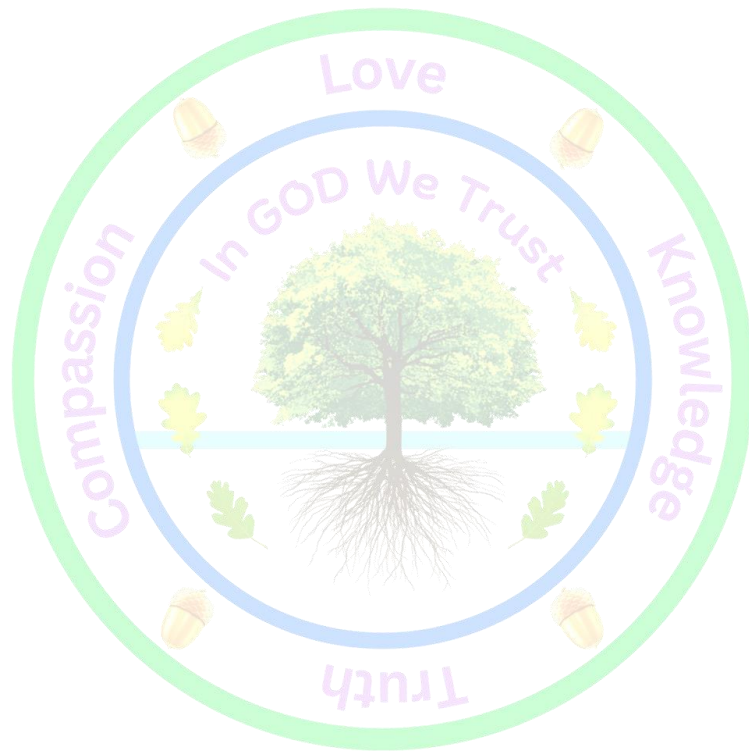

Area: Defence/Military

Description:

All Military personnel are to receive a salary increase of 30%

Title : Kingdom of Britain Military Budget
Area: Defence/Military

Description:

Increase in armed forces and special forces budget to £100 Billion per annum for the next 5 years.

This is for the purpose of:

- modernising offence and defence capabilities
- recruiting and training military personnel
- purchasing and/or building the latest technology i.e spacecraft, anti-gravity aircraft, ships, interstellar aircraft, aircraft carriers, vehicles, arms etc. (latest and newest technologies only)
- Supplies and uniforms

All ex-armed forces to be prioritised for housing, healthcare and given an allowance and training so they can find a new occupation/past-time.

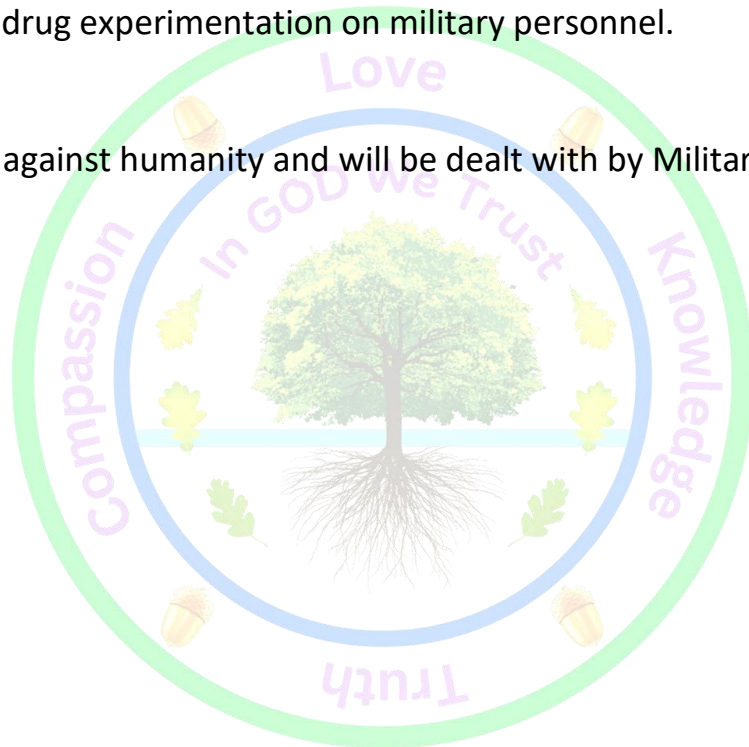
Title : Drug experimentation on military personnel
Area: Defence/Military

Description:

It is prohibited to use vaccinations, gene therapy, MRNA, DNA altering drugs and any other drug experimentation on military personnel.

Consequence:

This is a crime against humanity and will be dealt with by Military Court Martial.

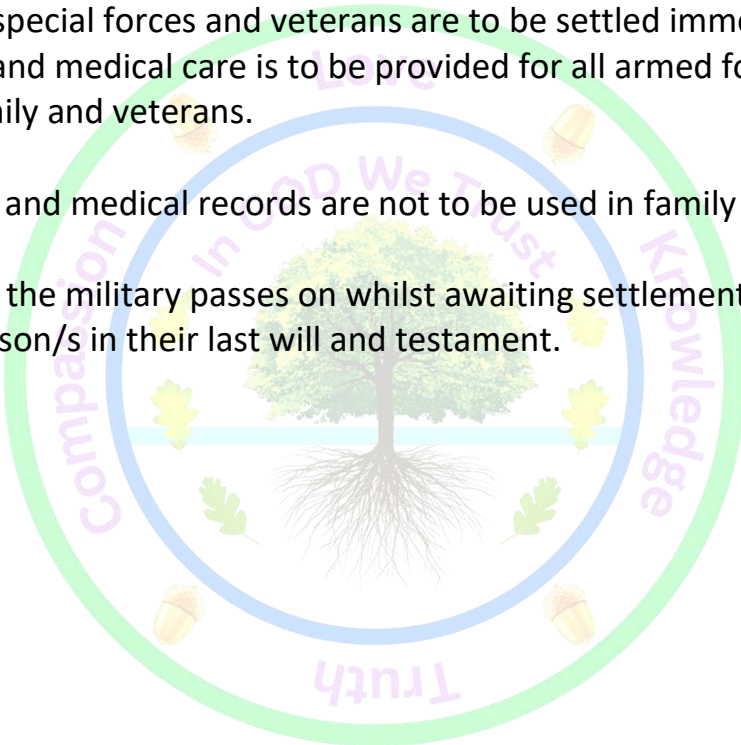
Title : Settling Military court cases
Area: Defence/Military

Description:

Any court cases, financial charges and benefit payments outstanding to the armed forces, special forces and veterans are to be settled immediately. Care, housing, food and medical care is to be provided for all armed forces members, immediate family and veterans.

Military health and medical records are not to be used in family courts.

If a member of the military passes on whilst awaiting settlement, this is to be paid to the person/s in their last will and testament.

Title : Manufacturing in Kingdom of Britain
Area: Manufacturing

Description:

80% of products manufactured within the Kingdom of Britain to be used and sold within the Kingdom of Britain. A small percentage (less than 20% of the total production) can be used for export.

All products manufactured and sold in the Kingdom of Britain are to use non-toxic, environmentally friendly materials. All manufacturing processes must cause no harm to We The People and our environment.

Production of all products containing toxic chemicals which are unsafe, for example: household cleaners, make-up and beauty products are to be seized. These products are to be removed from sale.

Human and animal body parts/animal testing are not to be used in any manufacturing process or product.

Investment in new products to be manufactured and sold only in the Kingdom of Britain. Financial assistance is available for new manufacturing projects.

Title : We The People's Right to repair products
Area: Manufacturing

Description:

Products produced in the Kingdom of Britain need to be reparable, recyclable and reusable.

We The People's Right to repair is in full effect with the following addendum:

- All Manufacturers must provide technical information
- Technical information on all products/ parts sold and or manufactured in the Kingdom of Britain
- Manufacturers must provide Schematics
- Manufacturers must supply parts for a minimum of 25 years
- In the Kingdom of Britain, the We The Peoples "Rights to Repair" supersedes Sellers and Manufacturers rights.

Title : Environmentally friendly packaging and disposable items
Area: Manufacturing

Description:

All packaging used in the manufacturing industry and all disposable packaging including plastics, cardboards and glass are to be of organically bio-degradable materials which cause no harm to the environment.

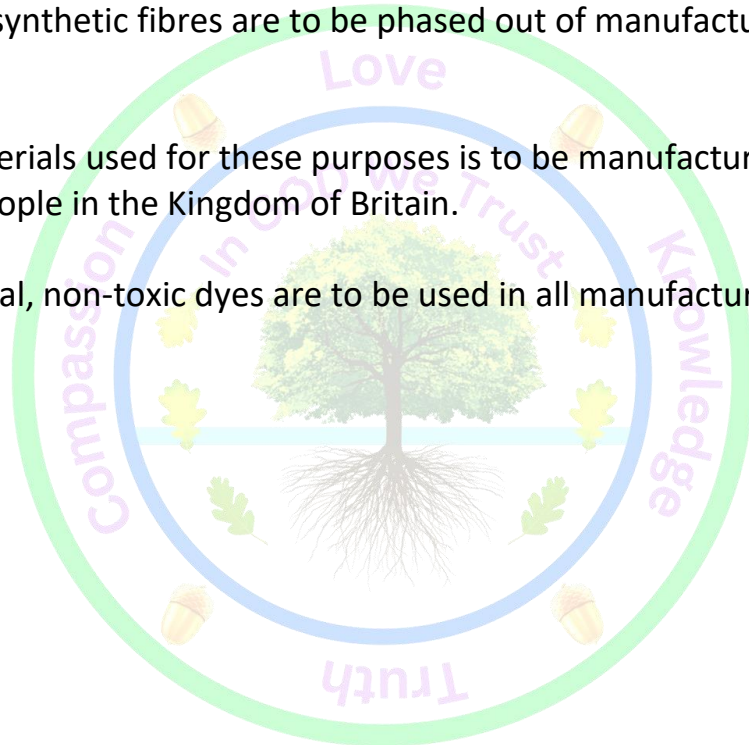
Title : Natural fibres in environmentally friendly materials
Area: Manufacturing

Description:

All clothing and bed linen items etc are to be made of 100% natural organic fibres. Use of synthetic fibres are to be phased out of manufacturing and sale over 2 years.

Cloth and materials used for these purposes is to be manufactured/produced for We The People in the Kingdom of Britain.

Organic, natural, non-toxic dyes are to be used in all manufacture of materials and textiles.

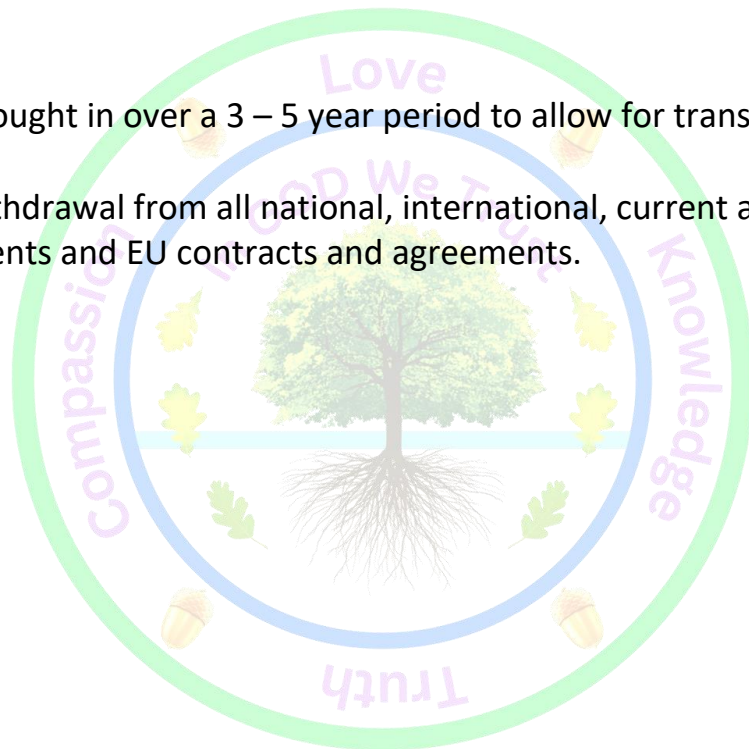
Title : Limitation on imports and cease Trade Agreements
Area: Import/Export

Description:

Import of products and services are to be no more that 10% of total economic usage.

This is to be bought in over a 3 – 5 year period to allow for transition.

Immediate withdrawal from all national, international, current and future trade agreements and EU contracts and agreements.

Title : Self sustainability and Community Agriculture
Area: Food/Farming/Agriculture

Description:

The Kingdom of Britain is able to feed all the We The People by becoming sustainably self-sufficient. This can be achieved by:

- Incentives to individuals and communities to grow their own food on verges, rooftops, front and rear gardens, and window boxes.
- All new residential buildings need to have facility to grow their own food to feed the occupants in a sustainable manner.
- Introduction of community and city gardens and allotments sufficient to feed their residents all year round.
- Cities and towns encouraged to re-purpose to achieve self-sufficiency in densely populated areas.

Title : Nutritious and health promoting agriculture
Area: Food/Farming/Agriculture

Description:

All food produce in the Kingdom of Britain needs to be GMO free, fertilised by natural non-chemical, toxin free and organic fertilisers.

All farming processes are to cause no harm to the environment and We The People.

All seeds to be organic and GMO free.

All foods to be safe and non-toxic for human and animal consumption.

Any pesticides required need to be natural and/or phased out altogether.

All food products sold in shops needs to be safe and do no harm to We The People. Current products containing harmful and toxic chemicals, pesticides etc needs to be removed from sale immediately.

All livestock feed to be provided free of charge to farmers this will come from the Prosperity Fund.

Consequences:

Any poisoning of We the People will be considered as intentional genocide and a crime against humanity.

Title : Funding for Organic Farming and Agriculture
Area: Food/Farming/Agriculture

Description:

A minimum investment of £100 million in farming and agriculture in the Kingdom of Britain. This is to go towards:

- Organic farming
- Organic livestock rearing
- Water irrigation
- Organic hay and straw production
- Organic fish farming
- Aquaculture

A 30% pay rise for all farm workers.

A transition from synthetic fertilisers will be completed within 1 year. All synthetic fertilizers are to be disposed of safely.

Consequences:

Any poisoning of We the People will be considered as intentional genocide and a crime against humanity.

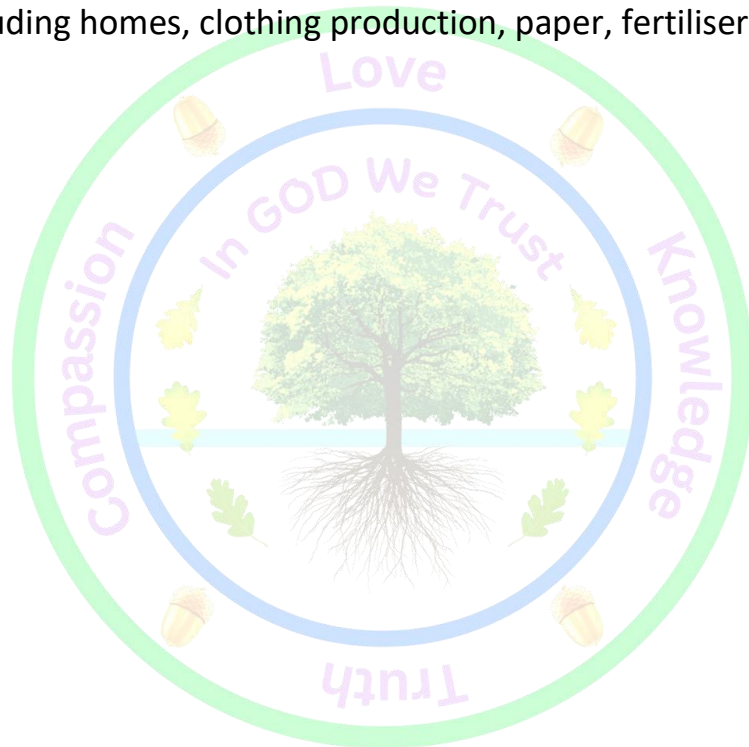

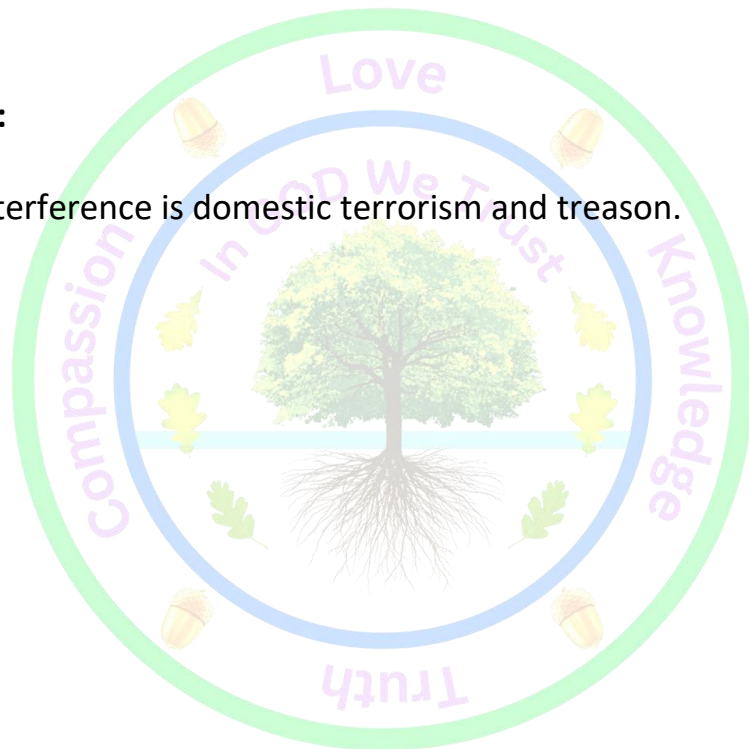
Title : EU and Legislation

All EU legislation, trade agreements, contracts and other foreign legislation is null and void.

Consequence:

Any foreign interference is domestic terrorism and treason.

Title : Securing food and product supply chain
Area: Food/Farming/Agriculture

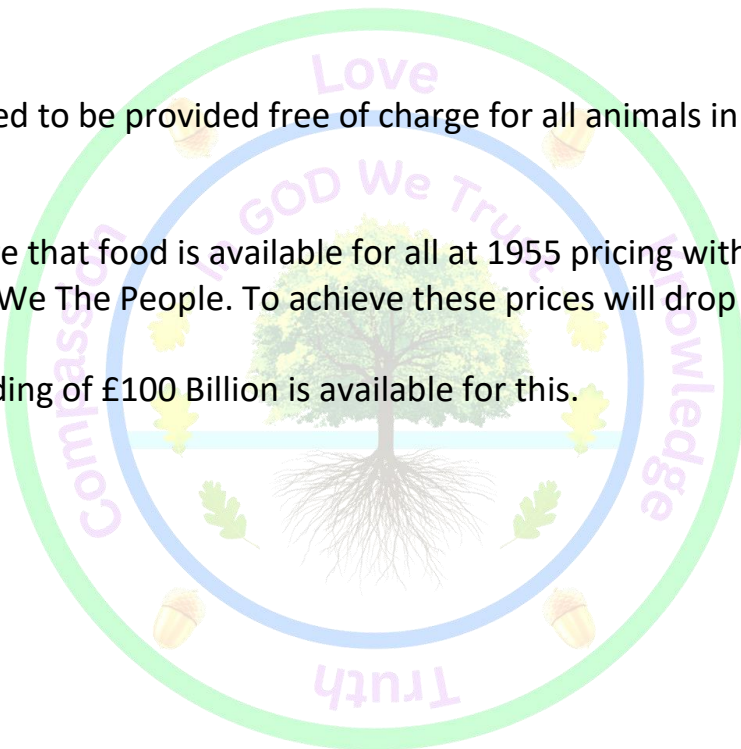
Description:

All food and product supply in the Kingdom of Britain belong to We The People.

All livestock feed to be provided free of charge for all animals in Kingdom of Britain.

This is to ensure that food is available for all at 1955 pricing with small profits reinvested for We The People. To achieve these prices will drop by 92%.

Prosperity funding of £100 Billion is available for this.

Title : Food production
Area: Food/Farming/Agriculture

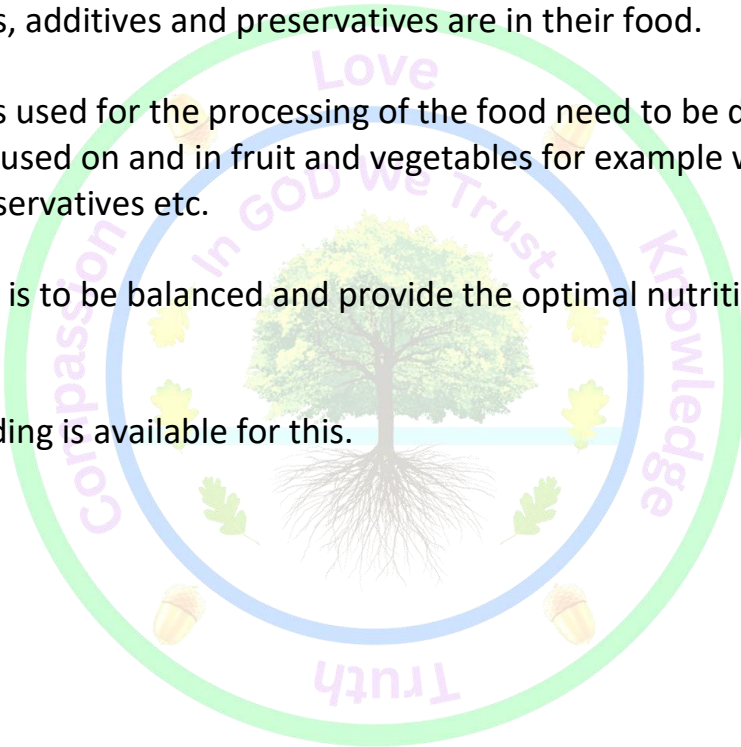
Description:

All food is to have its ingredients labelled clearly so everyone can understand what chemicals, additives and preservatives are in their food.

Any substances used for the processing of the food need to be declared this includes those used on and in fruit and vegetables for example waxing, pesticides, preservatives etc.

All animal feed is to be balanced and provide the optimal nutrition for the animal.

Prosperity funding is available for this.

Title : Farmland ownership
Area: Food/Farming/Agriculture

Description:

All farmland in The Kingdom of Britain is to be owned by nationals and national organisations.

It is prohibited for farmers to be in joint ventures with foreign nationals, foreign governments, foreign corporations, foreign and/or trans-Atlantic organisations.

Farmland currently owned by foreign nationals, foreign governments, foreign corporations, foreign and/or trans-Atlantic organisations will be peacefully safely, lawfully confiscated and reclaimed.

Title : Water suitable for consumption
Area: Clean water/Wastewater

Description:

Free clean drinking water is provided for all We The People of the Kingdom of Britain.

All water services including drainage and sewerage is provided free of charge. All water and related services are owned by We The People of the Kingdom of Britain.

Exportation of the Kingdom of Britain's clean drinking water is unlawful and banned.

Funding is available to ensure the supply of clean water and any repairs required to pipework etc.

Consequence:

Any deliberate poisoning of the water of We the People of the Kingdom of Britain is a crime against humanity.

All dumping of waste sewerage/effluent water in lakes, rivers and sea is considered an act of domestic terrorism, punishable by fines of £50 million per day which are to be used to rectify the damage.

Title : Education establishments closure
Area: Learning/Re-training

Description:

All educational establishments including training businesses, day care nurseries, all schools and universities in the Kingdom of Britain are prohibited from operating from now on.

This is to ensure that we transition to an alternate style of learning and training system. This includes systems like the Quantum Education System, person led learning based on truth and Natural Law.

Re-training is provided for all.

All learning for all ages will be provided free for We The People of the Kingdom of Britain.

Area: Learning/Re-training

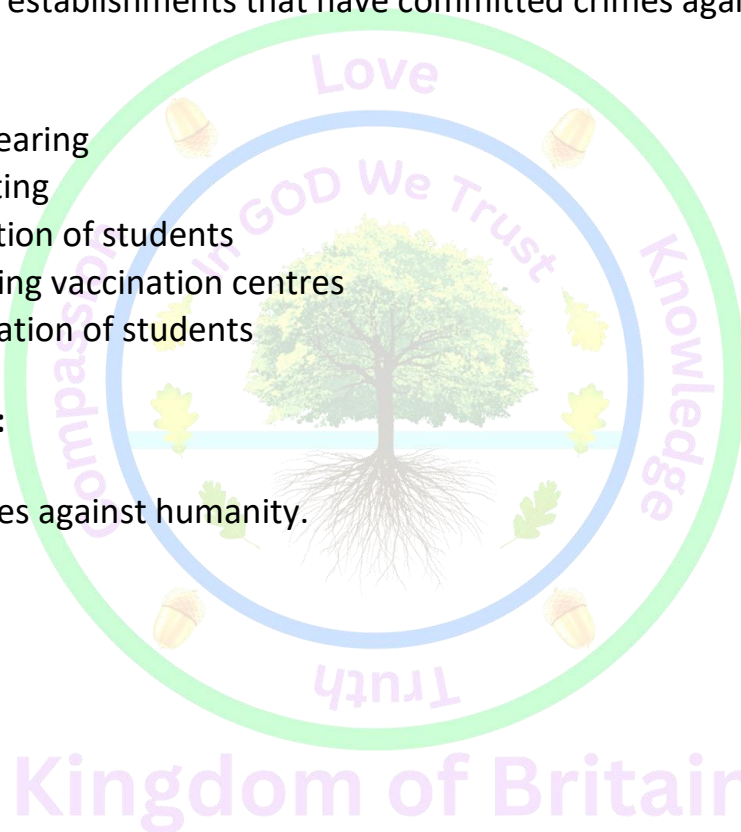
Description:

All books, online material, magazines etc containing the following, educational material are to be removed, destroyed and cease production immediately:

- Sex

- Drag queens
- Critical race theory
- Transgenderism
- Paedophilia and symbology
- Child grooming
- Violence
- Gun and knife crime
- Videos and films used for educational purposes containing the above information

Title : Restrictions and Limitations on Foreign Students

Area: Learning/Re-training

Description:

Foreign students are restricted from enrolling in and studying the following courses:

- Science
- Engineering
- Aerospace
- Technology
- Security and Defence
- Motor Industry
- Computer programming and coding
- Manufacturing
- Mining
- Oil
- Gas
- Farming and Fishing

Foreign student population in the schools in the Kingdom of Britain must not exceed 0.01% of the total school population at any given school.

These restrictions apply to all levels of education from pre-school to PHD level.

These also apply to schools offering online classes. The only exception is language schools exclusively offering online or remote classes.

Title : Eradication of Homelessness
Area: Housing/Shelter/Repurpose buildings

Description:

Homelessness and poverty for men, women, children and animals of the Kingdom of Britain is declared unlawful.

Housing and shelter are to be made available for all who require it. This requires homes to be built, buildings to be repurposed to ensure no one is homeless in the Kingdom of Britain.

All Government and Crown property now belongs to We The People to decide how they are to be utilised.

All churches and church property including graveyards are to be returned to We The People.

All purchasing of second homes is prohibited temporarily until all homelessness has ended.

Funding of £100 billion is available for home building and repurposing.

Title : Repurposing of buildings
Area: Housing/Shelter/Repurpose buildings

Description:

All Hospitals and health care facilities now belong to We The People and are to be repurposed as healing centres with the latest healing technologies and alternative treatments.

All privately owned town centre properties are to be refurbished with works commencing within 1 year. Any properties where this is not met will be taken over by We The People to convert.

All motorway service stations and motorway rest facilities are to provide facilities for families in particular a play area for children and feeding facilities for babies and toddlers. An area for animals is to be provided so they can exercise and relieve themselves.

Prosperity funding is available.

Title : Financial assistance for We The People
Area: Individual Income/Finance

Description:

Financial assistance is to be provided for all. This includes:

- 
- Mortgage owners
 - Rental tenants
 - People on benefits
 - People on pensions
 - People with disabilities
 - Carers of people with disabilities
 - Young people in care
 - Homeless people
 - People want their own home
 - Senior citizens who are receiving care and need assistance

Funding up to a maximum of £4000 per person per month is to be provided.

Pay rise of 30% to be given to individuals in the following industries:

- Construction
- Retail
- Hospitality
- Healthcare

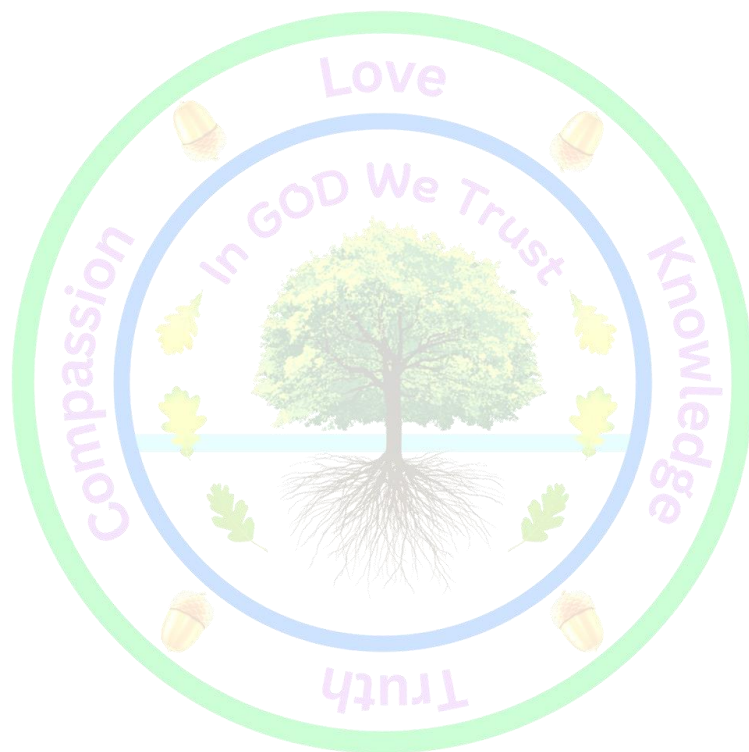
Only 5% of workers can be non-Kingdom of Britain citizens can be employed by any company.

Zero hours contracts are prohibited.

Title: Unlawful Mortgages and Rent Capping
Area: Individual Income/Finance

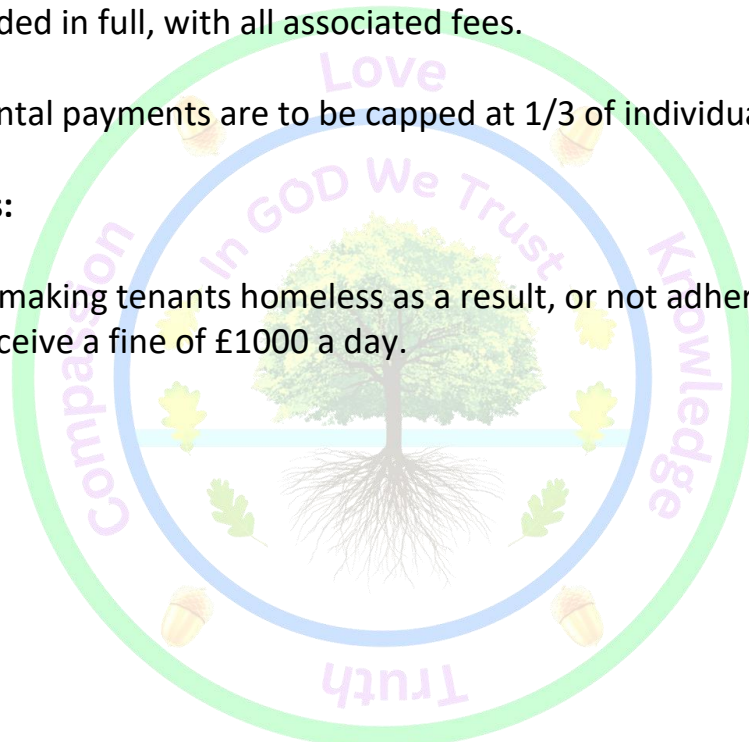
Description:

All mortgages are deemed to be unlawful/fraudulent in the Kingdom of Britain. All mortgage payments that were paid from the effective date of this decree must be refunded in full, with all associated fees.

All monthly rental payments are to be capped at 1/3 of individual net income.

Consequences:

Any landlords making tenants homeless as a result, or not adhering to this decree, will receive a fine of £1000 a day.

Title: Elimination of All Taxes
Area: Individual Income/Finance

Description:

Effective today, all listed taxes obligations below must be reset to ZERO balance. There shall be no further collection of taxes in the Kingdom of Britain other than the flat rate ten percent (10%) goods and services taxes applied only to non-exempt goods, new luxury goods and services as specified in this Natural Law Decree.

All taxes cause financial harm to We The People and therefore are prohibited in the Kingdom of Britain.

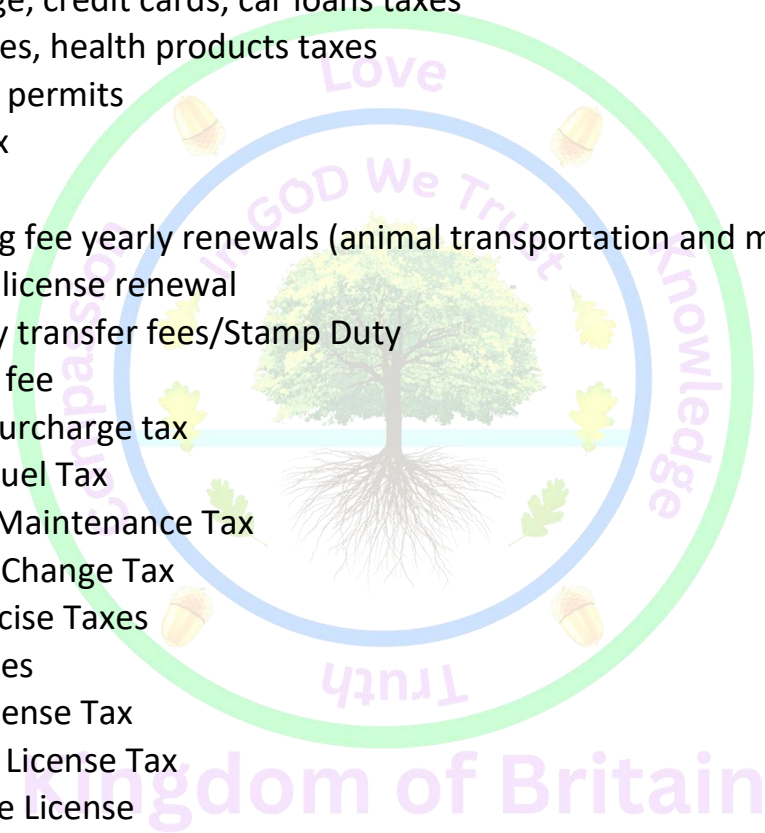

Title: Debt Forgiveness
Area: Individual Income/Finance

Description:

All debt is forgiven and cancellation of all financial obligations. This includes debt like

- 
- All Mortgages and interest
 - All credit card(s) and interest charges
 - Council taxes
 - All student loans
 - All Taxes owing
 - Vehicle Loan balance and taxes
 - Medical devices loan and medical bills
 - Covid Loans and fines (personal and small business loans)
 - Court Orders personal financial obligation
 - all that bear interest on the original balance or cost of the purchased item
 - Bank fees and credit cards fees.
 - Utility bills obligations: water, power, telephone, mobile, internet, gas (to heat home)
 - Secured and Unsecured loans of any type
 - Loans due to financial pressure as result of unlawful shutdown of business/loss of income
 - Bankruptcy debt
 - Monthly service charges on bank accounts
 - Debt collections services (third party collectors)

All debt causes emotional and financial harm to We The People and therefore are prohibited in the Kingdom of Britain.

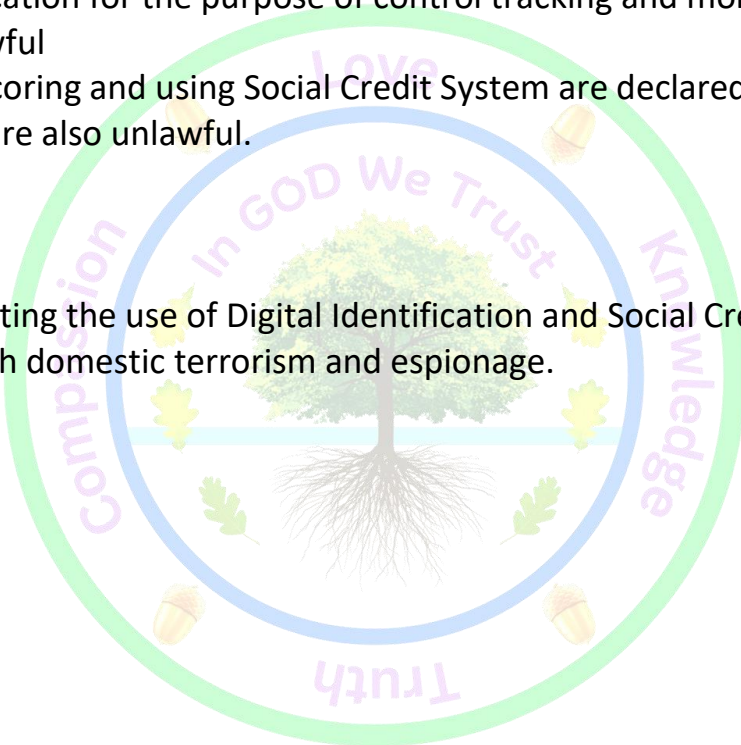
Title: Digital Identification and Social Credit Scoring
Area: Individual Income/Finance

Description:

Digital Identification for the purpose of control tracking and monitoring is declared unlawful
Social Credit Scoring and using Social Credit System are declared unlawful.
Credit checks are also unlawful.

Consequence:

Anyone promoting the use of Digital Identification and Social Credit Scoring will be charged with domestic terrorism and espionage.

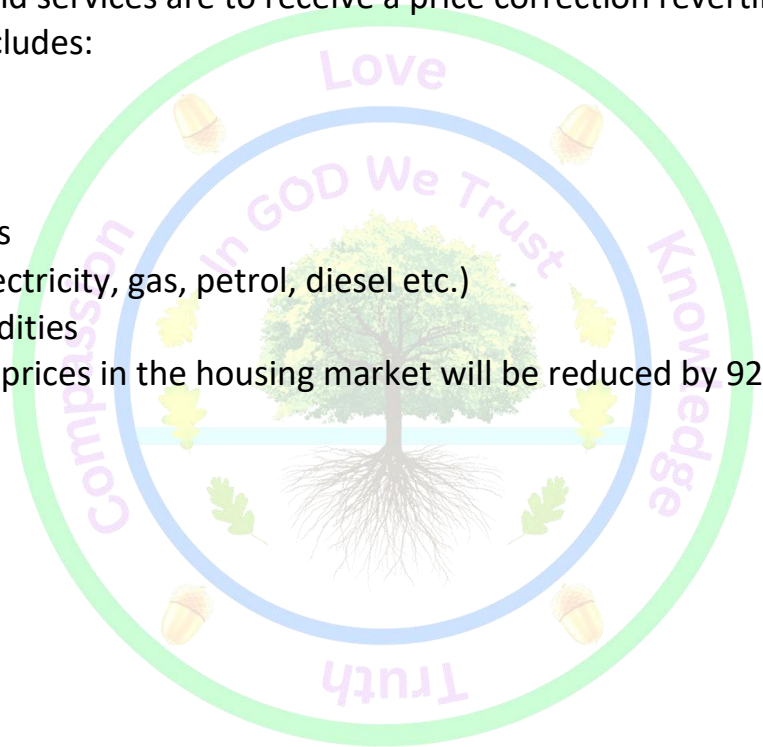
Title: Price Correction to 1955
Area: Individual Income/Finance

Description:

All products and services are to receive a price correction reverting to 1955 prices. This includes:

- Homes
- Services
- Food
- Products

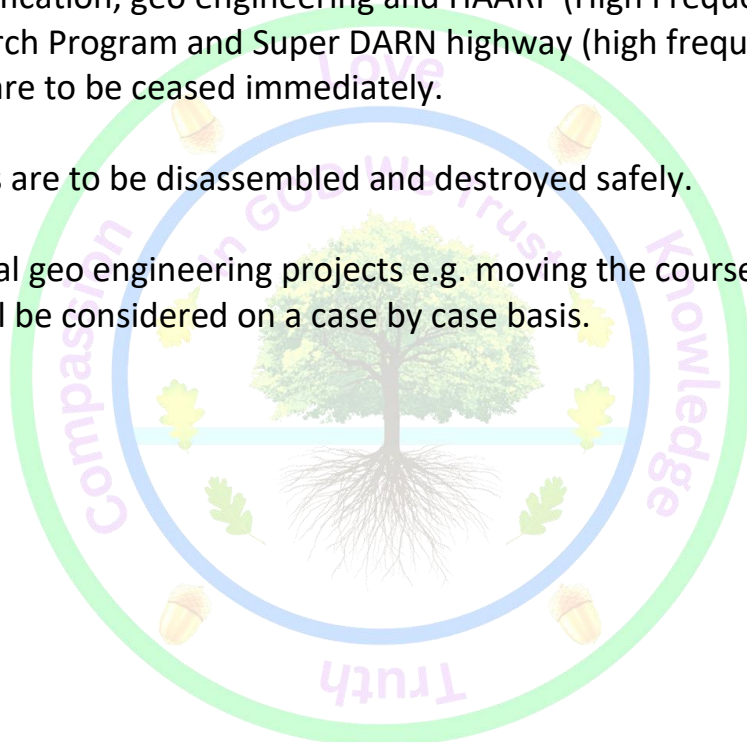
Title: Ceasing of HAARP weather modification and geo engineering.

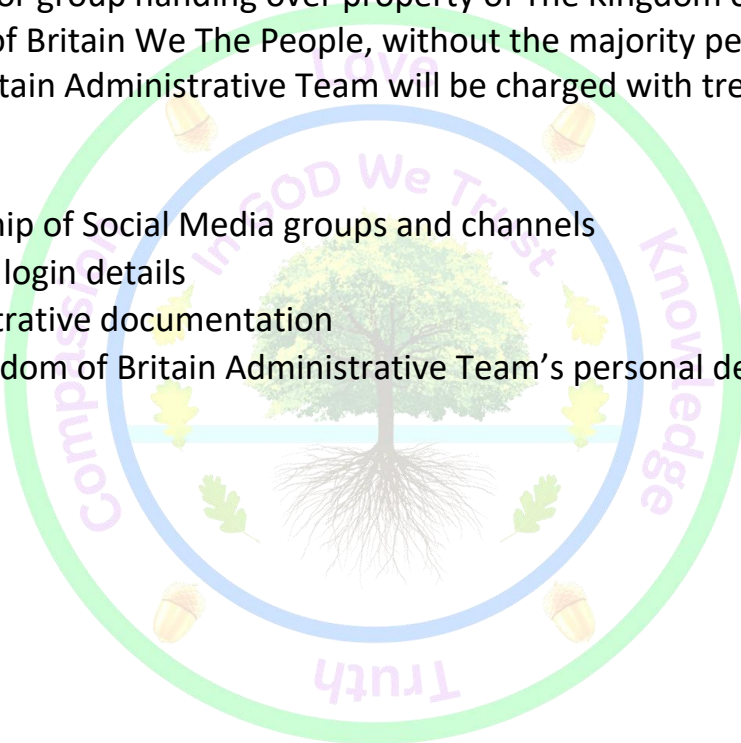

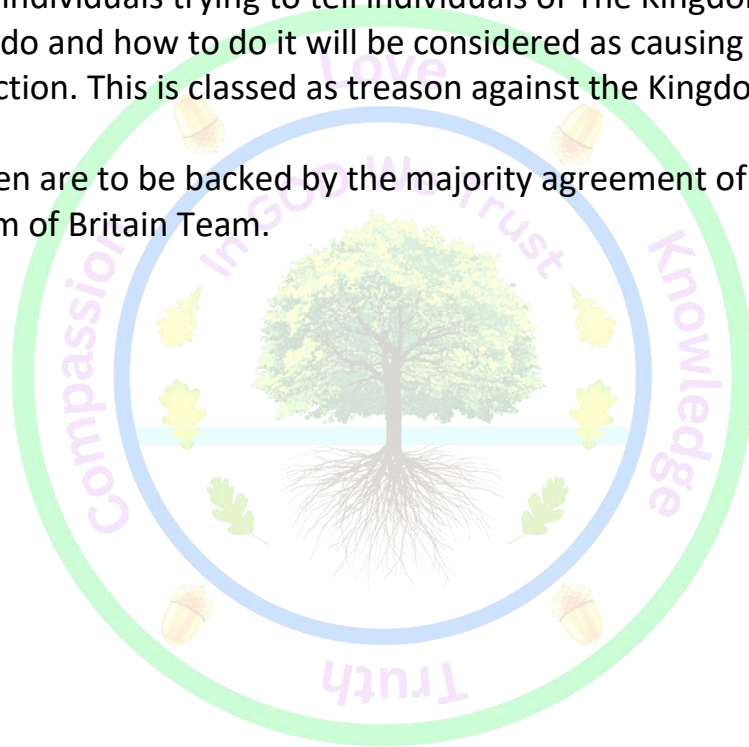

- Technology
- Security and Defence
- Motor Industry
- Computer programming and coding
- Manufacturing
- Mining
- Oil
- Gas
- Farming and Fishing
- Housing

Foreign worker population in the labour force in the Kingdom of Britain must not exceed 0.01% of the total labour force.

These restrictions apply to all industries.
